

Pfizer Independent Education Grants Request for Proposals (RFP)

Patient Education and Support for the Management of Migraine

Competitive Grant Program – Pfizer Internal Review Process

Overview

Patient education about migraine empowers individuals, helps diagnose those who are currently undiagnosed, improves treatment outcomes, and enhances overall quality of life for those affected by migraine. However, due to multiple factors including social/public, structural and self-stigma, migraine education is lacking for people living with migraine. There is a need for educational programs that increase availability and accessibility of current, evidence-based information and promote informed decision-making and active participation in one's migraine care.

Geographic Scope

Global

Project Types and Area of Interest

This competitive grant program seeks to support projects focused on addressing **patient education** on disease awareness, diagnosis, treatment, adherence, and general management of patients living with migraine.

Key Milestones

- Application submission deadline: August 15, 2023
- Anticipated decision notification date: September 2023

Funding Range and Project Length

Grant range expected to be from \$10,000 to \$150,000 USD. Maximum project length is 2 years.



I. Eligibility

Geographic Scope:

Global

Applicant Eligibility Criteria

- Only organizations are eligible to receive grants, not individuals or medical practice groups.
- Organizations representing patients and caregivers are encouraged to apply. In addition, professional
 associations, medical societies and other entities with a mission related to patient education and
 support for the management of migraine may apply.
- If the project involves multiple departments within an institution and/or between different institutions / organizations / associations, all departments and/or institutions must have a relevant role and the requesting organization must have a key role in the project.
- The applicant must be the project/program lead or an authorized designee of such individual (e.g., project/program lead's grant coordinator). The project/program lead must be an employee or independent contractor of the requesting organization.
- Requesting organization must be legally able to receive award funding directly from Pfizer Inc. We strongly recommend that applicants confirm this with their organization or institution prior to submitting an application. Grants awarded to organizations that are subsequently found to be unable to accept funding directly from Pfizer Inc. may be subject to rescission.

Migraine

General Area of Interest for this RFP:

Patient education about migraine empowers individuals, helps diagnose those who are currently undiagnosed, improves treatment outcomes, and enhances overall quality of life for those affected by migraine. However, due to social/public, structural and self-stigma, migraine education is severely lacking for people living with migraine. There is a need for educational programs that increase availability and accessibility of current, evidence-based information and promote informed decision-making and active participation in one's migraine care. Projects that will be considered for support will focus on addressing patient education on disease awareness, diagnosis, treatment, adherence, and general management of patients living with migraine. Pfizer is interested in educational initiatives that



encompass the following:

- Patient focused initiatives to educate, empower, and support patients living with migraine
- Patient educational resources about migraine disease, including but not limited to the following:
 - Epidemiology
 - Symptomology across migraine phases and diagnosis
 - o Pathophysiology (i.e., a type of neurological disorder, migraine threshold theory)
 - o Comorbid conditions (e.g., medical diagnoses, mental health conditions)
 - o Contributing factors and triggers (e.g., stress, insomnia, physical inactivity)
 - Biopsychosocial approach to treatment (e.g., pharmacotherapy, headache monitoring/trigger management, relaxation, biofeedback, cognitive behavioral interventions, lifestyle modifications, community support)
 - Medication overuse/"adaptation" headache
 - Migraine chronification
 - Migraine and pregnancy/post-partum
 - Parenting with migraine
 - Understanding and addressing migraine-related stigma
 - Finding community support/becoming an advocate
- Tools to help with adherence to pharmacotherapy and other interventions
- Resources to help patients communicate with caregivers, family and friends about migraine
- Resources to help patients communicate with their healthcare providers about migraine
- Resources to help patients navigate migraine in the workplace
- Initiatives that promote diversity, equity, and inclusion in patient education and migraine management, including but not limited to the following:
 - Resources geared toward patients in search of headache care adversely affected by social determinants of health (e.g., race/ethnicity, low health literacy, lack of access to physician care, limited insurance/financial coverage, etc.)
 - Dissemination strategies that increase reach to underserved and marginalized communities and demographics

It is not our intent to support clinical research projects. Projects evaluating the efficacy of therapeutic or diagnostic agents will not be considered.

Target Audience:

Patients, caregivers, and organizations representing patients and caregivers



Expected Approximate Monetary Range of Grant Applications:

- Individual projects requesting up to \$150,000 USD will be considered. The estimated total available budget related to this RFP is \$500,000 USD.
- In order to be competitive, projects that will have a more limited patient reach such as a one regional community or a smaller country should have a lower grant request amount in the \$10,000 to \$30,000 USD range
- Award amounts include direct costs, institutional overhead costs (capped at 28% per Pfizer policy), and indirect costs.

- RFP release date: July 5, 2023
- Grant Application due date: August 15, 2023
 Please note the deadline is 23:59 Eastern Standard Time (e.g., New York, GMT -5).
- Anticipated Grant Award Notification Date: September 2023
- Grants will be distributed following a fully executed agreement.
- Anticipated Project Start Date: November 2023 (2-year maximum project length, projects may be shorter than 2-years)

- If your grant is approved, your institution will be required to enter into a written grant agreement with Pfizer. Please click here to view the core terms of the agreement.

 agreement. Applicant is encouraged to share the core terms with counsel for approval prior to

Review and Approval Process:

About Pfizer Global Medical Grants

Pfizer Global Medical Grants (GMG) supports the global healthcare community's independent initiatives (e.g., research, quality improvement, or education) to improve patient outcomes in areas of unmet medical need that are aligned with Pfizer's medical and/or scientific strategies.

Pfizer's GMG competitive grant program involves a publicly posted general Request for Proposal (RFP) that provides detail regarding a general area of interest, sets timelines for review and approval, and uses an internal Pfizer review process to make final grant decisions. Organizations are invited to submit an application addressing the knowledge gaps as outlined in the specific RFP.

For all independent medical education grants, the grant requester (and ultimately the grantee) is responsible for the design, implementation, and conduct of the independent initiative supported by the grant. Pfizer must not be involved in any aspect of project development, nor the conduct of the independent education program.



Appendix

General RFP Submission Requirements

Applications will be accepted via the online portal listed in the How to Submit section. Project Proposals should be single-spaced using Calibri 12-point font and 1-inch margins. Note there is a 15-page limit exclusive of references. When uploading your Project Proposal please ensure it addresses the following sections:

Goals and Objectives

- Briefly state the overall goal of the project.
- List the objectives you plan to meet with your project, in terms of learning and expected outcomes.

Needs Assessment for the Project

• Include a description of your organization's needs assessment for this proposed project which may include a quantitative baseline data summary, initial metrics, or a project starting point (please cite data on gap analyses or relevant patient-level data that informs the stated objectives) in your target area.

Target Audience

Describe the primary audience(s) targeted for this project. Indicate whom you believe will directly benefit
from the project outcomes. Describe the overall population size as well as the size of your sample
population.

Project Design and Methods

 Describe the planned project, the educational approach, and the way the planned methods address the established need.

Innovation

• Explain what measures you have taken to assure that this project is original and does not duplicate other projects or materials already developed. Describe how this project builds upon existing work, pilot projects, or ongoing projects developed either by your institution or other institutions.

Evaluation and Outcomes

• In terms of the metrics used for the needs assessment, describe how your organization will determine if the gap was addressed for the target group. Identify the sources of data your organization anticipates using to make the determination. Describe how your organization is expected to collect and analyze the data. Explain the method used to control for other factors outside this project (e.g., use of a control group or comparison with baseline data). Quantify the amount of change expected from this project in terms the target audience. Describe how your organization will determine if the target audience was fully engaged in the project.

Dissemination Plan

 Describe how the project may have extended benefit beyond the grant. Will the teaching materials be made available to others to use? Will there be tools or resources that are made publicly available beyond the initial project. Describe how the project outcomes might be broadly disseminated.

Anticipated Project Timeline

Provide an anticipated timeline for your project including project start/end dates.



Additional Information

• If there is any additional information you feel Pfizer should be aware of concerning the importance of this project, please summarize here.

Organization Detail

Describe the attributes of the institutions / organizations / associations that will support and facilitate the
execution of the project and the leadership of the proposed project. Articulate the specific role of each
partner in the proposed project.
