



**Pfizer and Duke Announce an [Independent Medical Education Grant RFP](#)
*Providing Access to Learning Resources for
Tobacco Dependence Treatment*
*Competitive Grant Program – expert panel review process***

I. Background

Pfizer Global Medical Grants (GMG) supports the global healthcare community's independent initiatives (e.g., research, quality improvement, or education) to improve patient outcomes in areas of unmet medical need that are aligned with Pfizer's medical and/or scientific strategies.

Pfizer's GMG competitive grant program involves a publicly posted Request for Proposal (RFP) that provides detail regarding a specific area of interest, sets timelines for review and approval, and uses an expert review panel (ERP) to make final grant decisions. Organizations are invited to submit an application addressing the specific gaps in knowledge as outlined in the specific RFP.

The Duke Tobacco Treatment Education Program is designed to help medical providers provide more effective tobacco use treatment. This interactive course is a total of 15 hours with 9 hours of video-based training and 6 hours of live web-based training. The course will focus on skills and knowledge that are most useful to medical providers in their day-to-day practice including contemporary use of pharmacotherapy and effective behavioral techniques for treatment of tobacco dependence. The course will include multiple case examples with discussion to provide guidance for commonly encountered clinical situations.

II. Eligibility

<p>Applicant Eligibility Criteria</p>	<ul style="list-style-type: none"> • The following may apply: medical, dental, nursing, allied health, and/or pharmacy professional schools; healthcare institutions (both large and small); professional associations and medical societies; medical education companies; and other entities with a mission related to healthcare professional education and/or healthcare improvement. • Access to Duke’s educational curriculum in tobacco dependence treatment can only be awarded to organizations under this RFP, not individuals.

<p>General Area of Interest for this RFP:</p>	<ul style="list-style-type: none"> • To broaden access to Duke’s educational curriculum in tobacco dependence treatment for members of organizations which demonstrate a commitment to sustainable tobacco treatment education. Ultimately, this will improve patients’ awareness of the harms of tobacco and their chances of successfully stopping tobacco use. • Duke’s interactive web-based Tobacco Treatment Education Program for Medical Providers is designed to support health care providers develop important skills and deliver the best possible patient care. The 15 hour online course consists of videos, lectures, and a variety of interactive activities inviting participants to apply learning to actual cases. • It is expected that all applications will include a needs assessment detailing why access to online Tobacco Treatment Education Program would benefit the applying organization, and also an implementation plan detailing how the training will be utilized and disseminated. Furthermore, it is expected that successful organizations will commit to evaluating the learning outcomes from the program.

<p>Target Audience:</p>	<ul style="list-style-type: none"> • Healthcare institutions (both large and small), academic institutions, nursing, allied health and medical schools, and other organizations with a mission related to healthcare. • We will allow up to 40 attendees in each course. Individual applications requesting institution access for up to 20 participants will be considered.
<p>Expected Approximate Monetary Range of Grant Applications:</p>	<ul style="list-style-type: none"> • Please note that no funds will be transferred to the organizations to whom access to the online Tobacco Treatment Education Program is awarded. Access will be purchased on behalf of the successful organizations by Pfizer, and access granted by Duke. • The funding required for provision of access for users increases with the number of users included within the application, and as such, it is important that the projected outcomes of the application are commensurate with the number of program users requested. • Pfizer will clearly state in any approval notification, the review panel's rationale for supporting a given institution's application and the number of users that shall be granted access at that institution. • Access to the online Tobacco Treatment Education Program will be granted to successful applicants for a period of 6 months. Following the course, organizations will have another 3 months to evaluate the impact of the program and any changes that they have made to clinical practice as a result.
