#### I. Background

Pfizer Global Medical Grants (GMG) supports the global healthcare community's independent initiatives (e.g., research, quality improvement, or education) to improve patient outcomes in areas of unmet medical need that are aligned with Pfizer's medical and/or scientific strategies.

Pfizer's GMG competitive grant program involves a publicly posted Request for Proposal (RFP) that provides detail regarding a general area of interest, sets timelines for review and approval, and uses an internal Pfizer review process to make final grant decisions. Organizations are invited to submit an application addressing the knowledge gaps as outlined in the specific RFP.

For all independent medical education grants, the grant requester (and ultimately the grantee) is responsible for the design, implementation, and conduct of the independent initiative supported by the grant.

Pfizer must not be involved in any aspect of project development, nor the conduct of the independent education program.





# II. Eligibility

Geographic Scope:	Japan
Applicant Eligibility Criteria:	The following may apply: medical, dental, nursing, allied health, and/or pharmacy professional schools; healthcare institutions (both large and small); professional associations and medical societies; medical education companies; and other entities with a mission related to healthcare professional education and/or healthcare improvement.
	If the project involves multiple departments within an institution and/or between different institutions / organizations / associations. all institutions must have a relevant role and the requesting organization must have a key role in the project.
	For projects offering continuing education credit, the requesting organization must be accredited.

Clinical Area:	Cancer pain
General Area of Interest for this RFP:	Projects that will be considered for Pfizer support will focus on medical education projects for healthcare professionals (HCPs). The purpose of this project is to promote the treatment environment on comprehensive care and social support for patients with cancer pain.
	NOTES: It is not our intent to support clinical research projects. Projects evaluating the efficacy of therapeutic or diagnostic agents will not be considered.
Target Audience:	Health care professionals
Expected Approximate Monetary Range of Grant Applications:	Individual projects requesting up to 5,000,000JPY will be considered.
