



**Pfizer Announces an [Independent Medical Education Grant RFP](#)**  
***Emerging Therapies for Atopic Dermatitis  
and Alopecia Areata for Advanced Practice  
Providers and Primary Care Physicians***  
***Competitive Grant Program - internal Pfizer review process***

## **I. Background**

Pfizer Global Medical Grants (GMG) supports the global healthcare community's independent initiatives (e.g., research, quality improvement, or education) to improve patient outcomes in areas of unmet medical need that are aligned with Pfizer's medical and/or scientific strategies.

Pfizer's GMG competitive grant program involves a publicly posted general Request for Proposal (RFP) that provides detail regarding a general area of interest, sets timelines for review and approval, and uses an internal Pfizer review process to make final grant decisions. Organizations are invited to submit an application addressing the knowledge gaps as outlined in the specific RFP.

For all **independent medical education grants**, the grant requester (and ultimately the grantee) is responsible for the design, implementation, and conduct of the independent initiative supported by the grant. Pfizer must not be involved in any aspect of project development, nor the conduct of the independent education program.

## II. Eligibility

<b>Geographic Scope:</b>	United States
<b>Applicant Eligibility Criteria</b>	<ul style="list-style-type: none"> <li>• The following may apply: medical, dental, nursing, allied health, and/or pharmacy professional schools; healthcare institutions (both large and small); professional associations and medical societies; medical education companies; and other entities with a mission related to healthcare professional education and/or healthcare improvement.</li> <li>• If the project involves multiple departments within an institution and/or between different institutions / organizations / associations. all institutions must have a relevant role and the requesting organization must have a key role in the project.</li> <li>• For projects offering continuing education credit, the requesting organization must be accredited.</li> </ul>

## III. Requirements

<b>Clinical Area</b>	<ul style="list-style-type: none"> <li>• Atopic Dermatitis (AD) and Alopecia Areata (AA)</li> </ul>
<b>General Area of Interest for this RFP:</b>	<p>The landscape of treatment for inflammatory skin conditions, including Atopic Dermatitis and Alopecia Areata, is advancing, with more evidence and therapeutic options available to the community, including JAK inhibitors.</p> <p>Through this RFP, it is our intent to support educational projects that focus on addressing knowledge and practice gaps specific to the recognition, diagnosis, treatment, and overall care management of Atopic Dermatitis (AD) and Alopecia Areata (AA). Projects that will be considered for Pfizer support should focus on increasing the knowledge and understanding of:</p> <ol style="list-style-type: none"> <li>1) the pathophysiology of AA and AD with specific focus on immunologic pathways</li> <li>2) the epidemiology of the disease(s), including an understanding of the risk factors for the development of the disease(s), comorbidities, and safety events relevant to systemic therapies</li> <li>3) understanding the clinical manifestation of AD/AA, including a holistic review of the burden of disease (e.g.: psychosocial burden and associated autoimmune and atopic disorders)</li> <li>4) new advances in the treatment pathways of AA and AD</li> <li>5) mechanism of action of treatments in AA and AD</li> <li>6) the benefit/risk profile of systemic treatments for AA and AD treatments (e.g.: JAK inhibitors)</li> </ol>

	<p>When submitting your proposal, consider the target audience and note if your program will focus on 1) Atopic Dermatitis only, 2) Alopecia Areata only, or 3) programming that covers both AD and AA. Programs that offer a creative and cohesive approach to the knowledge gaps will be given priority.</p> <p><i>NOTE: It is not our intent to support clinical research projects. Research proposals will be denied as they are out of scope. Projects evaluating the efficacy of therapeutic or diagnostic agents will not be considered.</i></p>

Nurses, Nurse Practitioners, Physician Assistants who treat Atopic Dermatitis and Alopecia Areata and other medical dermatology conditions</li> <li>2. And/or Primary Care Physicians who treat Atopic Dermatitis and Alopecia Areata and other medical dermatology conditions.</li> </ol> </li> </ul>

Please click <a href="#">here</a> to view the core terms of the agreement.</li> <li>● Pfizer has drafted the terms of these agreements to be balanced and reasonable and to further the goals of both parties. Negotiating grant agreements requires significant resources, so please ensure that your institution (including your legal department) is able and willing to abide by these terms before proceeding with submission of your application as they will need to be accepted in their entirety.</li> </ul>

## Appendix A

### General RFP Submission Requirements

**Project Proposals should be single-spaced using Calibri 12-point font and 1-inch margins. Note there is a 15-page limit exclusive of references. Please include the following:**

<b>Goals and Objectives</b>	<ul style="list-style-type: none"> <li>Briefly state the overall goal of the project.</li> <li>List the objectives you plan to meet with your project, in terms of learning and expected outcomes.</li> </ul>
<b>Needs Assessment for the Project</b>	<ul style="list-style-type: none"> <li>Include a description of your organization’s needs assessment for this proposed project which may include a quantitative baseline data summary, initial metrics, or a project starting point (please cite data on gap analyses or relevant patient-level data that informs the stated objectives) in your target area.</li> </ul>
<b>Target Audience</b>	<ul style="list-style-type: none"> <li>Describe the primary audience(s) targeted for this project. Indicate whom you believe will directly benefit from the project outcomes. Describe the overall population size as well as the size of your sample population.</li> </ul>
<b>Project Design and Methods</b>	<ul style="list-style-type: none"> <li>Describe the planned project, the educational approach, and the way the planned methods address the established need.</li> </ul>
<b>Innovation</b>	<ul style="list-style-type: none"> <li>Explain what measures you have taken to assure that this project is original and does not duplicate other projects or materials already developed. Describe how this project builds upon existing work, pilot projects, or ongoing projects developed either by your institution or other institutions.</li> </ul>
<b>Evaluation and Outcomes</b>	<ul style="list-style-type: none"> <li>In terms of the metrics used for the needs assessment, describe how your organization will determine if the gap was addressed for the target group. Identify the sources of data your organization anticipates using to make the determination. Describe how your organization is expected to collect and analyze the data. Explain the method used to control for other factors outside this project (e.g., use of a control group or comparison with baseline data). Quantify the amount of change expected from this project in terms the target audience. Describe how your organization will determine if the target audience was fully engaged in the project.</li> </ul>
<b>Dissemination Plan</b>	<ul style="list-style-type: none"> <li>Describe how the project may have extended benefit beyond the grant. Will the teaching materials be made available to others to use? Will there be tools or resources that are made publicly available beyond the initial project. Describe how the project outcomes might be broadly disseminated.</li> </ul>

<b>Anticipated Project Timeline</b>	<ul style="list-style-type: none"><li>• Provide an anticipated timeline for your project including project start/end dates.</li></ul>
<b>Additional Information</b>	<ul style="list-style-type: none"><li>• If there is any additional information you feel Pfizer should be aware of concerning the importance of this project, please summarize here .</li></ul>
<b>Organization Detail</b>	<ul style="list-style-type: none"><li>• Describe the attributes of the institutions/organizations that will support and facilitate the execution of the project, the leadership of the proposed project, and the specific role of each institution in the proposed project.</li></ul>
<b>Budget Narrative</b>	<ul style="list-style-type: none"><li>• Please include a budget narrative that describes in greater detail the line items specified in the budget submitted within the application</li><li>• While estimating your budget please keep the following items in mind:<ul style="list-style-type: none"><li>○ Independent Medical Education Grants awarded by GMG cannot be used to purchase therapeutic assets (prescription or non-prescription).</li><li>○ Overhead rates of up to 28% of the total proposed project budget may be supported by Pfizer.</li></ul></li></ul>
