Quality Improvement Grants to Improve Identification and Management of Patients with ATTR-CM in Canada

Competitive Grant Program - internal Pfizer review process

I. Background

Pfizer Global Medical Grants (GMG) supports the global healthcare community's independent initiatives (e.g., research, quality improvement, or education) to improve patient outcomes in areas of unmet medical need that are aligned with Pfizer's medical and/or scientific strategies.

Pfizer's GMG competitive grant program involves a publicly posted Request for Proposal (RFP) that provides detail regarding a general area of interest, sets timelines for review and approval, and uses an internal Pfizer review process to make final grant decisions. Organizations are invited to submit an application addressing the practice gaps as outlined in the specific RFP.

For all independent quality improvement grants, the grant requester (and ultimately the grantee) is responsible for the design, implementation, and conduct of the independent initiative supported by the grant. Pfizer must not be involved in any aspect of project development, nor the conduct or monitoring of the quality improvement program.

II. Eligibility

Geographic Scope:	Canada
Applicant Eligibility Criteria	The following may apply: medical, dental, nursing, allied health, and/or pharmacy professional schools; healthcare institutions (both large and small); professional associations and medical societies; medical education companies; and other entities with a mission related to healthcare professional education and/or healthcare improvement.
	 Pfizer believes that every person deserves to be seen, heard, and cared for, and we work to further this goal by encouraging grant requestors with different backgrounds, perspectives, and experiences to apply
	 If the project involves multiple departments within an institution and/or between different institutions / organizations / associations. All institutions must have a relevant role and the requesting organization must have a key role in the project.
	 For projects offering continuing education credit, the requesting organization must be accredited.

General Area of Interest for this RFP:	Projects that will be considered for Pfizer support will focus on improving the identification and management of ATTR-CM patients by providing leadership, best practices, novel clinical pathways, support and/or training of HCPs within a multidisciplinary team environment in order to improve the quality of care for patients with ATTR-CM It is not our intent to support clinical research projects. Projects evaluating the efficacy of therapeutic or diagnostic agents will not be considered. Projects that involve the creation of a new Registry or support for an existing Registry are also out of scope.

Expected Approximate Monetary Range of Grant Applications:	 Individual projects requesting up to \$50,000 CAN will be considered. Pfizer anticipates awarding up to 5 projects.

Appendix A

Quality Improvement Project Full Proposal

Applications will be accepted via the online portal. Full Proposal documents should be no longer than 10 pages in length (12-point font and 1-inch margins) excluding Organization Detail and References. When uploading your Full Proposal please ensure it addresses the following*:

Goals and Objectives	 Briefly state the overall goal of the project. Also describe how this goal aligns with the focus of the RFP and the goals of the applicant organization(s). List the <i>overall</i> objectives you plan to meet with your project both in terms of learning and expected outcomes. Objectives should describe the target population as well as the outcomes you expect to achieve as a result of conducting the project.
Assessment of Need for the Project	 Please include a quantitative baseline data summary, initial metrics (e.g., quality measures), or a project starting point (please cite data on gap analyses or relevant patient-level data that informs the stated objectives) in your target area. Describe the source and method used to collect the data. Describe how the data was analyzed to determine that a gap existed. If a full analysis has not yet been conducted, please include a description of your plan to obtain this information.
Target Audience	 Describe the primary audience(s) targeted for this project. Also indicate whom you believe will directly benefit from the project outcomes. Describe the overall population size as well as the size of your sample population
Project Design and Methods	 Describe the planned project and the way it addresses the established need. If your methods include educational activities, please describe succinctly the topic(s) and format of those activities.
	 Please describe how the project submitted supports diversity, equity, and inclusion either through the study population targeted or through the project team that is directly involved
Innovation	 Explain what measures you have taken to assure that this project idea is original and does not duplicate other projects or materials already developed.
	 Describe how this project builds upon existing work, pilot projects, or ongoing projects developed either by your institution or other institutions related to this project.
Evaluation and Outcomes	 In terms of the metrics used for the needs assessment, describe how you will determine if the practice gap was addressed for the target group. Describe how you expect to collect and analyze the data.

	 Quantify the amount of change expected from this project in terms of your target audience.
	Describe how the project outcomes will be broadly disseminated.
Anticipated Project Timeline	 Provide an anticipated timeline for your project including project start/end dates
Additional Information	If there is any additional information you feel Pfizer should be aware of concerning the importance of this project, please summarize here
Organization Detail	 Describe the attributes of the institutions / organizations / associations that will support and facilitate the execution of the project and the leadership of the proposed project. Articulate the specific role of each partner in the proposed project.
Budget Detail	The budget amount requested must be in Canadian dollars (CAN).
	While estimating your budget please keep the following items in mind:
	Institutional overhead and indirect costs may be included within the grant request. Examples include human resources department costs, payroll processing and accounting costs, janitorial services, utilities, property taxes, property and liability insurance, and building maintenance as well as additional project expenses such as costs for publication, IRB / IEC review fees, software license fees, and travel. Please note: Pfizer does not provide funding for capital equipment.
	 The inclusion of these costs cannot cause the amount requested to exceed the budget limit set forth in the RFP.
	 It should be noted that grants awarded through GMG cannot be used to purchase therapeutic agents (prescription or non-prescription).
	 Pfizer maintains a company-wide, maximum allowed overhead rate of 28% for independent studies and projects
