



## Request for Proposals (RFP) Independent Medical Education Grants

### Optimizing Androgen Deprivation Therapy (ADT) in Advanced Prostate Cancer

Competitive Grant Program - internal company review process

#### I. Background

The Myovant Sciences-Pfizer Alliance supports the global healthcare community's independent initiatives (e.g., research, quality improvement, or education) to improve patient outcomes in areas of unmet medical need that are aligned with our joint medical and/or scientific strategies.

The Myovant Sciences-Pfizer Alliance's competitive grant program involves a publicly posted general Request for Proposal (RFP) that provides detail regarding general areas of interest, sets timelines for review and approval, and uses an internal review process to make final grant decisions. Organizations are invited to submit an application addressing the education gaps as outlined in the RFP.

For all independent medical education grants, the grant requester (and ultimately the grantee) is responsible for the design, implementation, and conduct of the independent initiative supported by the grant. Pfizer / Myovant must not be involved in any aspect of project development, nor the conduct of the independent education program.

#### II. Eligibility

Applicant Eligibility Criteria:	• The following may apply: medical, nursing, allied health, and/or pharmacy professional schools; healthcare institutions (both large and small); professional associations and medical societies; medical education companies; and other entities with a mission related to healthcare professional education and/or healthcare improvement.
	• If the project involves multiple departments within an institution and/or between different institutions / organizations / associations, all institutions must have a relevant role and the requesting organization must have a key role in the project.
	• For projects offering continuing education credit, the requesting organization must be accredited.

Project Proposals should be single-spaced using Calibri 12-point font and 1-inch margins. Note there is a 15-page limit exclusive of references. Please include the following:

Goals and Objectives	<ul> <li>Briefly state the overall goal of the project.</li> <li>List the objectives you plan to meet with your project, in terms of learning and expected outcomes.</li> </ul>
Needs Assessmentfor the Project	<ul> <li>Include a description of your organization's needs assessment for this proposed project which may include a quantitative baseline data summary, initial metrics, or a project starting point (please cite data on gap analyses or relevant patient-level data that informs the stated objectives) in your target area.</li> </ul>
Target Audience	<ul> <li>Describe the primary audience(s) targeted for this project. Indicate whom you believe will directly benefit from the project outcomes. Describe the overall population size as well as the size of your target population.</li> </ul>
Project Design and Methods	<ul> <li>Describe the planned project, the educational approach, and the way the planned methods address the established need.</li> </ul>
Innovation	<ul> <li>Explain what measures you have taken to assure that this project is original and does not duplicate other projects or materials already developed. Describe how this project builds upon existing work, pilot projects, or ongoing projects developed either by your institution or other institutions.</li> </ul>
Evaluation and Outcomes	<ul> <li>In terms of the metrics used for the needs assessment, describe how your organization will determine if the gap was addressed for the target group.
