



**Pfizer Announces a [Fellowship Grant RFP](#)**

## ***Infectious Disease Fellowship***

***Competitive Grant Program – using expert review panel***

### **I. Background**

Pfizer Global Medical Grants (GMG) supports the global healthcare community's independent initiatives (e.g., research, quality improvement or education) to improve patient outcomes in areas of unmet medical need that are aligned with Pfizer's medical and/or scientific strategies.

Pfizer's GMG competitive grant program involves a publicly posted Request for Proposal (RFP) that provides detail regarding a specific area of interest, sets timelines for review and approval, and uses an expert review panel (ERP). Institutions are invited to submit an application as outlined in the specific RFP.

This RFP reflects Pfizer's commitment to advancing research, innovation, and training for medical, nursing, and allied health professionals.

## II. Eligibility

Geographic Scope:	India
Applicant Eligibility Criteria	<ul style="list-style-type: none"> <li>Academic institution/ tertiary care hospitals with interest in supporting both established and emerging programs.</li> <li>Do <u>not</u> include the name of the potential fellow(s) in application materials. This grant will be awarded to an institution, not an individual.</li> <li>Institutions with fellowship programs that include independent research and a strong mentoring program. Clinical training may be included in the program but is not required.</li> <li>No aspect of the fellowship program can benefit Pfizer's business or a Pfizer asset.</li> <li>Examples of independent research include: observational studies and outcomes research studies where the primary focus is the scientific understanding of disease; use of screening tools and their impact on improvement of patient health. <ul style="list-style-type: none"> <li>Examples of research that would <b>not</b> be eligible include research involving the study and/or evaluation of any pharmaceutical product and basic science and/or fundamental research (in animal model, in-vitro, etc.).</li> </ul> </li> <li>Examples of clinical training include: educational time with an interdisciplinary team in review of case examples and relevant didactic training as well as use of tools for improvement in patient health for specific therapeutic areas or conditions.</li> <li>Fellow time spent in the clinical setting that is supported through grant funds must not be billed as patient care.</li> <li>Should possess valid FCRA certificate</li> </ul>

Specific Area of Interest for this RFP	The goal of this RFP is to offer salary support for Infectious Disease Fellowship programs. It is our intent to support institutions with fellowship programs for physicians that have a strong focus on clinical practice, research, and education to further the understanding of anti-microbial resistance in the country and work towards building stronger stewardship practices.

	<ul style="list-style-type: none"> <li>Grants will be awarded based on the strength of the requesting organization's ability to provide expert mentorship, training, and guidance to the fellow.</li> </ul>
<b>Requirements for Prospective Fellows:</b>	<ul style="list-style-type: none"> <li>Should be an Indian citizen, resident in India during the time of application and pursuit of the fellowship</li> </ul>
<b>Budget:</b>	<ul style="list-style-type: none"> <li>Grant funding is available to support one fellow for up to \$25,000 USD. The budget can only include salary and support of the fellow benefits. There is a total budget of \$250,000 USD for this program.</li> <li>Grant funds cannot be used for overhead or indirect costs.</li> <li>Funding will be awarded to the institution, not an individual.</li> <li>Fellow time spent in the clinical setting that is supported through grant funds must not be billed as patient care.</li> <li>No aspect of the fellowship program budget can reflect a benefit to Pfizer's business or a Pfizer asset.</li> </ul>

The proposal should be submitted in Word or a PDF. This document should be formatted with single-spaced using 12-point font and 1-inch margins and should not exceed 10-15 pages.

<b>Cover Page (not to exceed 1 page)</b>	<ul style="list-style-type: none"> <li>Title: Please include the fellowship title, and main institutions</li> <li>Abstract: Please include an abstract summary of your proposal including the goal of the fellowship, methods the institution uses to support the fellow's training and research, and assessment.</li> <li></li> </ul>
<b>Overall Goals and Objectives of the Fellowship</b>	<ul style="list-style-type: none"> <li>Describe the overall goal of the fellowship.</li> <li>Describe the focus of research and/or clinical training as applicable that is being supported in general terms based on the categorizations listed in this application.</li> </ul>
<b>Methods</b>	<ul style="list-style-type: none"> <li>Please describe the mentoring process.</li> <li>Include a description of the methods used to support the fellow and their research and/or clinical training.</li> </ul>
<b>Resources</b>	<ul style="list-style-type: none"> <li>Please describe the institution's academic, clinical training, and research capacity.</li> <li>Describe the facilities/resources that are made available to the fellow.</li> <li>Provide a summary of relevant past work that is applicable.</li> </ul>
<b>Challenges</b>	<ul style="list-style-type: none"> <li>Please provide a summary of potential challenges and of plans for addressing those challenges</li> </ul>
