#### I. Background

Pfizer Global Medical Grants (GMG) supports the global healthcare community's independent initiatives (e.g., research, quality improvement, or education) to improve patient outcomes in areas of unmet medical need that are aligned with Pfizer's medical and/or scientific strategies.

Pfizer's GMG competitive grant program involves a publicly posted general Request for Proposal (RFP) that provides detail regarding a general area of interest, sets timelines for review and approval, and uses an internal Pfizer review process to make final grant decisions. Organizations are invited to submit an application addressing the knowledge gaps as outlined in the specific RFP.

For all **independent medical education grants**, the grant requester (and ultimately the grantee) is responsible for the design, implementation, and conduct of the independent initiative supported by the grant. Pfizer must not be involved in any aspect of project development, nor the conduct of the independent education program.

# II. Eligibility

Geographic Scope:	Japan
Applicant Eligibility Criteria	The following may apply: medical, dental, nursing, allied health, and/or pharmacy professional schools; healthcare institutions (both large and small); professional associations and medical societies; medical education companies; and other entities with a mission related to healthcare professional education and/or healthcare improvement. If the project involves multiple departments within an institution and/or between different institutions / organizations / associations. all institutions must have a relevant role and the requesting organization must have a key role in the project.

# **III. Requirements**

Clinical Area	Acute Leukemia
General Area of Interest for this RFP:	Pfizer support will focus on the medical educational projects for health care professionals to accelerate improvement of the treatment environment on comprehensive care and social support for patients with blood tumors (acute leukemia [acute lymphoblastic leukemia: ALL and acute myeloid leukemia: AML]).
	The treatment outcomes of adult acute leukemia treatment have been greatly improved by novel agents (antibody drugs, molecular targeted drugs and immune cell therapies), allowing acute leukemia patients to improve the prognosis <sup>1)-6).</sup> On the other hand, to optimize the treatments, adequate diagnosis and risk management of side effects by novel agents and complications after stem cell transplantation are very important issues to improve the treatment outcomes and QOLs for the acute leukemia patients <sup>7)-8</sup> .
	In view of the recent environmental changes in acute leukemia treatment, Pfizer will support educational projects that lead to improvement of treatment outcomes and QOLs for acute leukemia patients.
	This RFP is for educational projects that address the following issues, but not limited to them.
	<ul> <li>Education projects that lead to improvement of complication risk induced by stem cell transplantation for acute leukemia patients.</li> </ul>
	Education projects that lead to treatment optimization and QOL     improvement by management of side effects induced by acute leukemia





	treatments.
	<ul> <li>Education projects for primary physicians, industrial physicians, and professionals involved in employment support, aimed at balancing treatment and rehabilitation for acute leukemia patients</li> </ul>
	<ul> <li>Education projects that lead to the elimination of disparities in medical expertise on acute leukemia of health care professionals, and/or the medical facility and regional differences of diagnosis, treatment, and care environments.</li> </ul>
	<ul> <li>Education projects that lead to improve awareness and understanding to the disease characteristics, diagnosis, testing, treatment, and palliative medicine of acute leukemia.</li> </ul>
	Educational projects can be considered in the form of events, satellite symposia, hands-on seminars, workshops, online courses, printed materials, and so on.
	It is not our intent to support clinical research projects. Projects evaluating the efficacy of therapeutic or diagnostic agents will not be considered. In addition, it is not also our intent to support guideline development (e.g., clinical treatment guidelines) from the viewpoint of COI.
Target Audience:	Physicians, nurses, pharmacists, clinical laboratory technologists and other health care professionals involved in testing, diagnosis, treatment, comprehensive care, and social support for acute leukemia patients

Negotiating grant agreements requires significant resources, so please ensure that your institution (including your legal department) is able and willing to abide by these terms before proceeding with submission of your application as they will need to be accepted in their entirety.
Review and Approval Process:	Grant requests received in response to a general RFP are reviewed by Pfizer to make final grant decisions.

Pfizer must complete payment procedure by the end of November 2022. Please confirm the procedure of your institution for receiving our grant before proceeding with submission of your application.

#### **General RFP Submission Requirements**

Project Proposals should be single-spaced using Calibri 12-point font and 1-inch margins. Note there is a 15-page limit exclusive of references. Please include the following:

Goals and Objectives	Briefly state the overall goal of the project.
	<ul> <li>List the objectives you plan to meet with your project, in terms of learning and expected outcomes.</li> </ul>
Needs Assessment for the Project	<ul> <li>Include a description of your organization's needs assessment for this proposed project which may include a quantitative baseline data summary, initial metrics, or a project starting point (please cite data on gap analyses or relevant patient-level data that informs the stated objectives) in your target area.</li> </ul>
Target Audience	• Describe the primary audience(s) targeted for this project. Indicate whom you believe will directly benefit from the project outcomes. Describe the overall population size as well as the size of your sample population.
Project Design and Methods	<ul> <li>Describe the planned project, the educational approach, and the way the planned methods address the established need.</li> </ul>
Innovation	<ul> <li>Explain what measures you have taken to assure that this project is original and does not duplicate other projects or materials already developed. Describe how this project builds upon existing work, pilot projects, or ongoing projects developed either by your institution or other institutions.</li> </ul>
Evaluation and Outcomes	• In terms of the metrics used for the needs assessment, describe how your organization will determine if the gap was addressed for the target group. Identify the sources of data your organization anticipates using to make the determination. Describe how your organization is expected to collect and analyze the data. Explain the method used to control for other factors outside this project (e.g., use of a control group or comparison with baseline data). Quantify the amount of change expected from this project in terms the target audience. Describe how your organization will determine if the target audience was fully engaged in the project.
Dissemination Plan	<ul> <li>Describe how the project may have extended benefit beyond the grant. Will the teaching materials be made available to others to use? Will there be tools or resources that are made publicly available beyond the initial project. Describe how the project outcomes might be broadly disseminated.</li> </ul>
Anticipated Project Timeline	<ul> <li>Provide an anticipated timeline for your project including project start/end dates</li> </ul>





Additional Information	<ul> <li>If there is any additional information you feel Pfizer should be aware of concerning the importance of this project, please summarize here.</li> </ul>
Organization Detail	<ul> <li>Describe the attributes of the institutions/organizations that will support and facilitate the execution of the project, the leadership of the proposed project, and the specific role of each institution in the proposed project.</li> </ul>
Budget Narrative	<ul> <li>Please include a budget narrative that describes in greater detail the line items specified in the budget submitted within the application</li> </ul>
