



Pfizer Announces a [Quality Improvement Grant RFP](#)

Antimicrobial Resistance Testing and Stewardship to Improve Hospitalized Patients' Health Outcomes

Competitive Grant Program - internal Pfizer review process

I. Background

Pfizer Global Medical Grants (GMG) supports the global healthcare community's independent initiatives (e.g., research, quality improvement, or education) to improve patient outcomes in areas of unmet medical need that are aligned with Pfizer's medical and/or scientific strategies.

Pfizer's GMG competitive grant program involves a publicly posted Request for Proposal (RFP) that provides detail regarding a general area of interest, sets timelines for review and approval, and uses an internal Pfizer review process to make final grant decisions. Organizations are invited to submit an application addressing the practice gaps as outlined in the specific RFP.

For all independent quality improvement grants, the grant requester (and ultimately the grantee) is responsible for the design, implementation, and conduct of the independent initiative supported by the grant. Pfizer must not be involved in any aspect of project development, nor the conduct or monitoring of the quality improvement program.

Applicant Eligibility Criteria	<ul style="list-style-type: none"> • The following may apply: medical, dental, nursing, allied health, and/or pharmacy professional schools; healthcare institutions (both large and small); professional associations and medical societies; and other entities with a mission related to healthcare improvement. • If the project involves multiple departments within an institution and/or between different institutions / organizations / associations. All institutions must have a relevant role and the requesting organization must have a key role in the project. • Projects in resource limited settings will be given higher priority and the nature of these settings should be clearly outlined.

General Area of Interest for this RFP:	<p>In 2022, Pfizer launched Accord, an Accord for a Healthier World, a first-of-its-kind initiative to enable sustained, equitable access to high-quality, safe and effective medicines and vaccines with the potential to improve the health of 1.2 billion people living in lower-income countries around the world. Rwanda, Ghana, Malawi, Senegal and Uganda are the first five countries to commit to join the Accord. Many of the other countries within the geographic scope of this initiative are among the countries covered by the geographic scope of this RFP, low-income countries in Sub-Saharan Africa.</p> <p>Reference</p> <p>An Accord for a Healthier World Pfizer</p> <p>Projects that will be considered for Pfizer support will focus on system-level changes with measurable improvement, around antimicrobial resistance (AMR) in healthcare settings with a focus on building capacity or performing in-hospital laboratory testing and integrating into the associated institutional</p>

	<p>or national antimicrobial stewardship programs.</p> <p>Proposals should</p> <ul style="list-style-type: none"> • Adhere to local laws and regulations regarding antimicrobial therapy prescribing, use, and treatment practices. • Include a comprehensive monitoring and evaluation scheme that specifically details endpoints for program outcomes. All programs proposed must consider how laboratory testing for resistance relate to antimicrobial stewardship programs and once enacted, how they will change therapy consumption patterns and what effect this will have on patient health outcomes. Programs should not compromise patient safety and positive health outcomes to reach unfounded targets. • Reference to a country's AMR Plan and the status as reported to the World Health Organisation would be useful particularly as it relates to laboratory testing, laboratory capacity and training activities. • Sustainability of the initiative must be discussed in the proposal. <p>Proposals that describe how its programmatic intervention can be expanded to other settings or regions to improve patient health outcomes are encouraged.</p> <p><i>It is not our intent to support clinical research projects. Projects evaluating the efficacy of therapeutic or diagnostic agents will not be considered.</i></p>

Quality Improvement Project Full Proposal

Applications will be accepted via the online portal. Full Proposal documents should be no longer than 10-15 pages in length (12-point font and 1-inch margins) excluding Organization Detail and References. When uploading your Full Proposal please ensure it addresses the following*:

Goals and Objectives	<ul style="list-style-type: none"> Briefly state the overall goal of the project. Also describe how this goal aligns with the focus of the RFP and the goals of the applicant organization(s). List the <i>overall</i> objectives you plan to meet with your project both in terms of learning and expected outcomes. Objectives should describe the target population as well as the outcomes you expect to achieve as a result of conducting the project.
Assessment of Need for the Project	<ul style="list-style-type: none"> Please include a quantitative baseline data summary, initial metrics (e.g., quality measures), or a project starting point (please cite data on gap analyses or relevant patient-level data that informs the stated objectives) in <i>your</i> target area. Describe the source and method used to collect the data. Describe how the data was analyzed to determine that a gap existed. If a full analysis has not yet been conducted, please include a description of your plan to obtain this information.
Target Audience	<ul style="list-style-type: none"> Describe the primary audience(s) targeted for this project. Also indicate whom you believe will directly benefit from the project outcomes. Describe the overall population size as well as the size of your sample population
Project Design and Methods	<ul style="list-style-type: none"> Describe the planned project and the way it addresses the established need. If your methods include educational activities, please describe succinctly the topic(s) and format of those activities
Innovation	<ul style="list-style-type: none"> Explain what measures you have taken to assure that this project idea is original and does not duplicate other projects or materials already developed. Describe how this project builds upon existing work, pilot projects, or ongoing projects developed either by your institution or other institutions related to this project.
Evaluation and Outcomes	<ul style="list-style-type: none"> In terms of the metrics used for the needs assessment, describe how you will determine if the practice gap was addressed for the target group. Describe how you expect to collect and analyze the data.

	<ul style="list-style-type: none"> Quantify the amount of change expected from this project in terms of your target audience. Describe how the project outcomes will be broadly disseminated.

Articulate the specific role of each partner in the proposed project.
Budget Detail	<ul style="list-style-type: none"> The budget amount requested must be in U.S. dollars (USD). While estimating your budget please keep the following items in mind: <ul style="list-style-type: none"> General organizational running costs such as insurances, heating, lighting, rent, building maintenance may be included. Pfizer does not provide funding for capital purchases (infrastructure expenses such as equipment, purchases of software or software licenses, technology or bricks and mortar). Equipment hire/leasing is acceptable and may be included in project budget. The inclusion of these costs cannot cause the amount requested to exceed the budget limit set forth in the RFP. It should be noted that grants awarded through GMG cannot be used to purchase Pfizer therapeutic agents (prescription or non-prescription).
