Overview

This competitive grant program seeks to improve healthcare professional understanding of Sphingosine-1-phosphate (S1P) receptor modulation in the treatment of UC.

Europe, Canada, Japan, South Korea, Australia, New Zealand, Israel

Project Types

An independent medical education grant is a type of grant which consists of Pfizer funding for independent medical education activities or initiatives which serve to maintain, develop, or increase the knowledge, skills, and/or professional performance of a healthcare professional (e.g. continuing medical education, continuing health education, continuing education). These activities or initiatives may or may not be accredited.

Funding Range and Project Length

Individual projects requesting up to \$150,000 USD will be considered. The estimated total available budget related to this RFP is \$300,000 USD. Project length will be a maximum of 18 months.



I. Eligibility

Geographic Scope:

• Europe, Canada, Japan, South Korea, Australia, New Zealand, Israel

Applicant Eligibility Criteria

- Only organizations are eligible to receive grants, not individuals or medical practice groups.
- The following may apply: medical, nursing, allied health, and/or pharmacy professional schools; healthcare institutions (both large and small); professional associations and medical societies; medical education companies; and other entities with a mission related to healthcare professional education and/or healthcare improvement.
- If the project involves multiple departments within an institution and/or between different institutions / organizations / associations. All institutions must have a relevant role and the requesting organization must have a key role in the project.

Ulcerative Colitis

General Area of Interest for this RFP:

- Projects that will be considered for Pfizer support will focus on providing education to healthcare
 professionals (HCPs) involved in diagnosis, treatment, and management of patients with UC.
 Proposals should include, but are not limited to the following areas:
 - Understanding the S1P receptor modulation MOA and its role in the pathophysiology of UC
 - Potential role of S1P receptor modulators in clinical management if UC
 - Facilitating shared decision making between the HCP and patient and/or caregiver to select the optimal treatment plan after discussing all available options, their pros and cons, personal preferences, and the circumstances of the patient
- All activity formats will be considered under this RFP (live in-person, live virtual, enduring courses, congress coverage, social media and digital platforms
- It is not our intent to support clinical research projects. Projects evaluating the efficacy of therapeutic or diagnostic agents will not be considered.

Target Audience

• Gastroenterologists, internal medicine specialists, primary care physicians, nurses and other health care professionals involved in the diagnosis, treatment, and management of patients with UC.

• Individual projects requesting up to \$150,000 USD will be considered. The estimated total available budget related to this RFP is \$300,000 USD.

About Pfizer Global Medical Grants

Pfizer Global Medical Grants (GMG) supports the global healthcare community's independent initiatives (e.g., research, quality improvement, or education) to improve patient outcomes in areas of unmet medical need that are aligned with Pfizer's medical and/or scientific strategies.

Pfizer's GMG competitive grant program involves a publicly posted general Request for Proposal (RFP) that provides detail regarding a general area of interest, sets timelines for review and approval, and uses an internal Pfizer review process to make final grant decisions. Organizations are invited to submit an application addressing the knowledge gaps as outlined in the specific RFP.

For all independent medical education grants, the grant requester (and ultimately the grantee) is responsible for the design, implementation, and conduct of the independent initiative supported by the grant. Pfizer must not be involved in any aspect of project development, nor the conduct of the independent education program.



General RFP Submission Requirements

Applications will be accepted via the online portal listed in the How to Submit section. Project Proposals should be single-spaced using Calibri 12-point font and 1-inch margins. Note there is a 15-page limit exclusive of references. When uploading your Project Proposal please ensure it addresses the following sections:

Goals and Objectives

- Briefly state the overall goal of the project.
- List the objectives you plan to meet with your project, in terms of learning and expected outcomes.

Needs Assessment for the Project

Include a description of your organization's needs assessment for this proposed project which may
include a quantitative baseline data summary, initial metrics, or a project starting point (please cite data
on gap analyses or relevant patient-level data that informs the stated objectives) in your target area.

Target Audience

 Describe the primary audience(s) targeted for this project. Indicate whom you believe will directly benefit from the project outcomes. Describe the overall population size as well as the size of your sample population.

Project Design and Methods

• Describe the planned project, the educational approach, and the way the planned methods address the established need.

Innovation

• Explain what measures you have taken to assure that this project is original and does not duplicate other projects or materials already developed. Describe how this project builds upon existing work, pilot projects, or ongoing projects developed either by your institution or other institutions.

Evaluation and Outcomes

• In terms of the metrics used for the needs assessment, describe how your organization will determine if the gap was addressed for the target group. Identify the sources of data your organization anticipates using to make the determination. Describe how your organization is expected to collect and analyze the data. Explain the method used to control for other factors outside this project (e.g., use of a control group or comparison with baseline data). Quantify the amount of change expected from this project in terms the target audience. Describe how your organization will determine if the target audience was fully engaged in the project.

Dissemination Plan
