

# Pfizer Independent Medical Education RFP

## *Non-Muscle Invasive Bladder Cancer*

### *Emerging Markets Needs Assessment*

Competitive Grant Program –Pfizer Internal Review Process



#### Overview

This competitive program seeks to support organizations who will conduct a thorough educational needs assessment in the area of non-muscle invasive bladder cancer (NMIBC).



#### Geographic Scope

Argentina, Brazil, Mexico, Colombia, United Arab Emirates, Saudi Arabia, India, Taiwan, Hong Kong and Turkey.



#### Project Types and Area of Interest

Pfizer will support the development of a comprehensive educational needs assessment of urologists and medical oncologists related to high risk non-muscle invasive bladder cancer (NMIBC).

Pfizer's intent is for the results of the needs assessment to be shared with the entire medical community in order to enhance future medical education programs that eliminate barriers and close gaps experienced by HCPs. In addition, the results will be used to inform educational budget planning and future Requests for Proposals (RFPs).



#### Key Milestones

- Application submission deadline: **August 9, 2023**
- Anticipated decision notification date: **September 12, 2023**
- Anticipated project start date: **November 1, 2023**



#### Funding Range and Project Length

Individual projects requesting up to \$40,000 USD will be considered. A total of \$200,000 USD is available for this RFP.

Project duration can be up to 9 months.

## I. Eligibility

---

### Geographic Scope:

- Latin America: Argentina, Brazil, Mexico, Colombia
- Middle East: United Arab Emirates, Saudi Arabia
- Asia/Eurasia: India, Taiwan, Hong Kong, Turkey

Proposals may be for a single country, a single region, or for a global effort including all countries of interest.

### Applicant Eligibility Criteria

- Only organizations are eligible to receive grants, not individuals or medical practice groups.
- The following may apply: medical, nursing, allied health, and/or pharmacy professional schools; healthcare institutions (both large and small); professional associations and medical societies; medical education companies; and other entities with a mission related to healthcare professional education and/or healthcare improvement.
- If the project involves multiple departments within an institution and/or between different institutions / organizations / associations. All institutions must have a relevant role and the requesting organization must have a key role in the project.

### Clinical Area

- Non-Muscle Invasive Bladder Cancer

### General Area of Interest for this RFP:

- It is our intent to provide an independent grant to an organization or organizations who will conduct a thorough educational needs assessment in the area of non-muscle invasive bladder cancer (NMIBC).
- Needs Assessment projects that will be considered for Pfizer support will focus on identifying some or all of the following example areas:
  - The most up-to-date local epidemiological data and disease burden of NMIBC
  - Accurately describing a typical patient journey and current treatment approaches of High-Risk NMIBC
  - How has the impact of Bacillus Calmette Guerin (BCG) shortage impacted patient care and how is patient care being managed during this period of BCG shortage?
  - What is the current level of physician understanding of the mechanism of action of immunotherapy (IO) treatment in early bladder cancer and why/how it is relevant in disease progression?
  - What is the current role of urologists in the treatment of NMIBC?
  - Understand how oncologists and urologists will collaborate on NMIBC treatment decision making/patient care, specifically as a result of a potential subcutaneous IO formulation available for NMIBC patients; what might ongoing coordination of care for patients with NMIBC look like?
    - What are the anticipated barriers as new IO agents become available?
    - What resources are needed for urologists and other healthcare professionals to improve their experience and comfort level with IO therapy?

- What is the role of nurses or community health workers working with urologists as well as the role of the nurse related to the management of IO related adverse events?

*It is not our intent to support clinical research projects. Projects evaluating the efficacy of therapeutic or diagnostic agents will not be considered.*

### Target Audience

- Urologists and medical oncologists and other healthcare professionals involved in the care of patients with NMIBC

### Expected Approximate Monetary Range of Grant Applications:

- Individual projects requesting up to \$40,000 USD will be considered. The estimated total available budget related to this RFP is \$200,000 USD.
- Award amounts include direct costs, institutional overhead costs (capped at 28% per Pfizer policy), and indirect costs.

Pfizer Global Medical Grants (GMG) supports the global healthcare community's independent initiatives (e.g., research, quality improvement, or education) to improve patient outcomes in areas of unmet medical need that are aligned with Pfizer's medical and/or scientific strategies.

Pfizer's GMG competitive grant program involves a publicly posted general Request for Proposal (RFP) that provides detail regarding a general area of interest, sets timelines for review and approval, and uses an internal Pfizer review process to make final grant decisions. Organizations are invited to submit an application addressing the knowledge gaps as outlined in the specific RFP.

For all independent medical education grants, the grant requester (and ultimately the grantee) is responsible for the design, implementation, and conduct of the independent initiative supported by the grant. Pfizer must not be involved in any aspect of project development, nor the conduct of the independent education program.

### General RFP Submission Requirements

Applications will be accepted via the online portal listed in the [How to Submit](#) section. Project Proposals should be single-spaced using Calibri 12-point font and 1-inch margins. Note there is a 15-page limit exclusive of references. When uploading your Project Proposal please ensure it addresses the following sections:

#### Goals and Objectives

- Briefly state the overall goal of the project.
- List the objectives you plan to meet with your project, in terms of learning and expected outcomes.

#### Needs Assessment for the Project

- Include a description of your organization's needs assessment for this proposed project which may include a quantitative baseline data summary, initial metrics, or a project starting point (please cite data on gap analyses or relevant patient-level data that informs the stated objectives) in your target area.

#### Target Audience

- Describe the primary audience(s) targeted for this project. Indicate whom you believe will directly benefit from the project outcomes. Describe the overall population size as well as the size of your sample population.

#### Project Design and Methods

- Describe the planned project, the educational approach, and the way the planned methods address the established need.

#### Innovation

- Explain what measures you have taken to assure that this project is original and does not duplicate other projects or materials already developed. Describe how this project builds upon existing work, pilot projects, or ongoing projects developed either by your institution or other institutions.

#### Evaluation and Outcomes

- In terms of the metrics used for the needs assessment, describe how your organization will determine if the gap was addressed for the target group. Identify the sources of data your organization anticipates using to make the determination. Describe how your organization is expected to collect and analyze the data. Explain the method used to control for other factors outside this project (e.g., use of a control group or comparison with baseline data). Quantify the amount of change expected from this project in terms the target audience. Describe how your organization will determine if the target audience was fully engaged in the project.

#### Dissemination Plan

- Describe how the project may have extended benefit beyond the grant. Will the teaching materials be made available to others to use? Will there be tools or resources that are made publicly available beyond the initial project. Describe how the project outcomes might be broadly disseminated.

### Anticipated Project Timeline

- Provide an anticipated timeline for your project including project start/end dates.

### Additional Information

- If there is any additional information you feel Pfizer should be aware of concerning the importance of this project, please summarize here

### Organization Detail

- Describe the attributes of the institutions / organizations / associations that will support and facilitate the execution of the project and the leadership of the proposed project. Articulate the specific role of each partner in the proposed project.

### Budget Detail

- Please include a budget narrative that describes in greater detail the line items specified in the budget submitted within the application
- While estimating your budget please keep the following items in mind:
  - Independent Medical Education Grants awarded by GMG cannot be used to purchase therapeutic assets (prescription or non-prescription).
