I. Eligibility

Geographic Scope:

United States

Applicant Eligibility Criteria

- Only organizations are eligible to receive grants, not individuals or medical practice groups.
- The following may apply: medical, dental, nursing, allied health, and/or pharmacy professional schools; healthcare institutions (both large and small); professional associations and medical societies; medical education companies; and other entities with a mission related to healthcare professional education and/or healthcare improvement.
- If the project involves multiple departments within an institution and/or between different institutions / organizations / associations. All institutions must have a relevant role and the requesting organization must have a key role in the project.

Clinical Area

RSV – Older Adults

General Area of Interest for this RFP:

Respiratory syncytial virus (RSV) is a common respiratory virus that can cause serious illness in infants, young children, and older adults (especially those 65 years and older), potentially leading to pneumonia, bronchiolitis, and other respiratory complications. In older adults, RSV infection can also lead to hospitalization and death. The CDC reports that each year it is estimated between 60,000-160,000 older adults in the United States are hospitalized and 6,000-10,000 of them die due to RSV infection.

Through this RFP it is our intent to support educational programs that provide pharmacists with updates on RSV in older adults, including health equity considerations. Program objectives may include, but are not limited to, the following:

- o Describe the burden of RSV disease and clinical manifestations of RSV disease in older adults
- Discuss the mechanism of action (MOA) of RSV vaccines
- Summarize the efficacy and safety data for RSV prevention options for older adults
- Understand the role pharmacists play in educating older adults about RSV prevention.
- Understand the role pharmacists play in reducing health disparities in older adults, including with RSV prevention

All activity types will be considered, with an emphasis on innovative programs that are designed to meet the needs of a large pharmacist audience.

It is not our intent to support clinical research projects. Projects evaluating the efficacy of therapeutic or diagnostic agents will not be considered.

- Individual projects requesting up to \$200,000 will be considered. The estimated total available budget related to this RFP is \$550,000
- Award amounts include direct costs, institutional overhead costs (capped at 28% per Pfizer policy), and indirect costs.

 goals of both parties. Negotiating grant agreements requires significant resources, so please ensure
 that your institution (including your legal department) is able and willing to abide by these terms before
 proceeding with submission of your application as they will need to be accepted in their entirety.
- Payment will only be made to requesting Institution.



Review and Approval Process

 Grant requests received in response to a general RFP are reviewed by Pfizer to make final grant decisions.

About Pfizer Global Medical Grants

Pfizer Global Medical Grants (GMG) supports the global healthcare community's independent initiatives (e.g., research, quality improvement, or education) to improve patient outcomes in areas of unmet medical need that are aligned with Pfizer's medical and/or scientific strategies.

Pfizer's GMG competitive grant program involves a publicly posted general Request for Proposal (RFP) that provides detail regarding a general area of interest, sets timelines for review and approval, and uses an internal Pfizer review process to make final grant decisions. Organizations are invited to submit an application addressing the knowledge gaps as outlined in the specific RFP.

For all independent medical education grants, the grant requester (and ultimately the grantee) is responsible for the design, implementation, and conduct of the independent initiative supported by the grant. Pfizer must not be involved in any aspect of project development, nor the conduct of the independent education program.



Appendix

General RFP Submission Requirements

Applications will be accepted via the online portal listed in the How to Submit section. Project Proposals should be single-spaced using Calibri 12-point font and 1-inch margins. Note there is a 15-page limit exclusive of references. When uploading your Project Proposal please ensure it addresses the following sections:

Goals and Objectives

- Briefly state the overall goal of the project.
- List the objectives you plan to meet with your project, in terms of learning and expected outcomes.

Needs Assessment for the Project

Include a description of your organization's needs assessment for this proposed project which may
include a quantitative baseline data summary, initial metrics, or a project starting point (please cite data
on gap analyses or relevant patient-level data that informs the stated objectives) in your target area.

Target Audience

Describe the primary audience(s) targeted for this project. Indicate whom you believe will directly benefit
from the project outcomes. Describe the overall population size as well as the size of your sample
population.

Project Design and Methods

• Describe the planned project, the educational approach, and the way the planned methods address the established need.

Innovation

Explain what measures you have taken to assure that this project is original and does not duplicate other
projects or materials already developed. Describe how this project builds upon existing work, pilot
projects, or ongoing projects developed either by your institution or other institutions.

Evaluation and Outcomes

• In terms of the metrics used for the needs assessment, describe how your organization will determine if the gap was addressed for the target group. Identify the sources of data your organization anticipates using to make the determination. Describe how your organization is expected to collect and analyze the data. Explain the method used to control for other factors outside this project (e.g., use of a control group or comparison with baseline data). Quantify the amount of change expected from this project in terms the target audience. Describe how your organization will determine if the target audience was fully engaged in the project.

Dissemination Plan

 Describe how the project may have extended benefit beyond the grant. Will the teaching materials be made available to others to use? Will there be tools or resources that are made publicly available beyond the initial project. Describe how the project outcomes might be broadly disseminated.

Anticipated Project Timeline

Provide an anticipated timeline for your project including project start/end dates.

Organization Detail

Describe the attributes of the institutions / organizations / associations that will support and facilitate the
