#### **Project Types and Area of Interest**

The landscape of treatment for AA is advancing, with more evidence and potential breakthrough therapeutic options available to patients. Through this RFP it is our intent to support educational projects that focus on addressing knowledge and practice gaps specific to the recognition, diagnosis, treatment, and overall care management of AA in the pediatric population.

- Anticipated decision notification date: November 29, 2023
- Anticipated project start date: January 12, 2024

#### Funding Range and Project Length

Individual projects requesting up to \$200,000 will be considered. Total budget available is \$600,000.



## I. Eligibility

#### Geographic Scope:

United States

#### Applicant Eligibility Criteria

- Only organizations are eligible to receive grants, not individuals or medical practice groups.
- The following may apply: medical, nursing, allied health, and/or pharmacy professional schools; healthcare institutions (both large and small); professional organizations/medical societies; medical education companies; and other entities with a mission related to healthcare professional education and/or healthcare improvement.
- If the project involves multiple departments within an institution and/or between different institutions / organizations / associations. All institutions must have a relevant role and the requesting organization must have a key role in the project.
- The applicant must be the project/program lead or an authorized designee of such individual (e.g., project/program lead's grant coordinator).
- The project/program lead must be an employee or independent contractor of the requesting organization.
- Requesting organization must be legally able to receive award funding directly from Pfizer Inc. We
  strongly recommend that applicants confirm this with their organization or institution prior to submitting
  an application. Grants awarded to organizations that are subsequently found to be unable to accept
  funding directly from Pfizer Inc. may be subject to rescission.

### **II. Requirements**

#### **Clinical Area:**

Alopecia Areata

#### General Area of Interest for this RFP:

The Pediatric Dermatology workforce is limited, with shortages impacting patient care. This impacts the delivery of dermatologic care to pediatric and adolescent (age 12-18 years) patients. Projects that will be considered for Pfizer support should focus on meeting the educational needs of the dermatologists, nurses, nurse practitioners, and physician assistants on managing pediatric AA. Identifying and closing education gaps among dermatologists and advanced practice providers are vital to the successful delivery of care to pediatric patients.

Educational projects can be live and/or virtual formats that may also include interactivity will be considered for Pfizer support and should focus on increasing the knowledge and understanding of:

- 1. the pathophysiology of AA with specific focus on immunologic pathways
- 2. the epidemiology of the disease, with a specific focus on the incidence and prevalence rates in pediatric patients
- 3. understanding the clinical manifestations of AA, including the comorbidities and the patient burden of disease
- 4. new and emerging systemic therapies in AA
- 5. how to assess severity of disease in AA



It is not our intent to support clinical research projects. Projects evaluating the efficacy of therapeutic or diagnostic agents will not be considered.

#### **Target Audience:**

• The target audience for the project should include dermatologists, pediatric dermatologists, nurses, nurse practitioners, and/or physician assistants who treat AA.

#### Expected Approximate Monetary Range of Grant Applications:

- Individual projects requesting up to \$200,000 will be considered. The estimated total available budget related to this RFP is \$600,000
- Award amounts include direct costs, institutional overhead costs (capped at 28% per Pfizer policy), and indirect costs.

Applications will be accepted via the online portal listed in the How to Submit section. Project Proposals should be single-spaced using Calibri 12-point font and 1-inch margins. Note there is a 15-page limit exclusive of references. When uploading your Project Proposal please ensure it addresses the following sections:

#### **Goals and Objectives**

- Briefly state the overall goal of the project.
- List the objectives you plan to meet with your project, in terms of learning and expected outcomes.

#### Needs Assessment for the Project

Include a description of your organization's needs assessment for this proposed project which may
include a quantitative baseline data summary, initial metrics, or a project starting point (please cite data
on gap analyses or relevant patient-level data that informs the stated objectives) in your target area.

#### **Target Audience**

• Describe the primary audience(s) targeted for this project. Indicate whom you believe will directly benefit from the project outcomes. Describe the overall population size as well as the size of your sample population.

#### **Project Design and Methods**

• Describe the planned project, the educational approach, and the way the planned methods address the established need.

#### Innovation

• Explain what measures you have taken to assure that this project is original and does not duplicate other projects or materials already developed. Describe how this project builds upon existing work, pilot projects, or ongoing projects developed either by your institution or other institutions.

#### **Evaluation and Outcomes**

• In terms of the metrics used for the needs assessment, describe how your organization will determine if the gap was addressed for the target group. Identify the sources of data your organization anticipates using to make the determination. Describe how your organization is expected to collect and analyze the data. Explain the method used to control for other factors outside this project (e.g., use of a control group or comparison with baseline data). Quantify the amount of change expected from this project in terms the target audience. Describe how your organization will determine if the target audience was fully engaged in the project.
