2024 Inflammatory Bowel Disease (IBD) Fellowship – United States

Competitive Grant Program – using Expert Review Panel



Overview

It is our intent to support institutions with fellowship programs for gastroenterologists/physicians working in the field of IBD that have a strong organizational focus on diversity, equity, and inclusion and a strong training focus on clinical practice, research, and education.



Geographic Scope

United States



Project Types and Area of Interest

The goal of this RFP is to offer salary support for IBD fellowship programs. It is our intent to support fellowship programs at institutions with clinical training programs in regions where there are continued workforce challenges and that have a strong focus on clinical practice, research, and education to further the understanding of IBD.

Programs that prioritize diversity, equity, and inclusion (DEI) principles, address health care disparities, and social determinants of health are always encouraged. Preference will be given to programs that are located in states underserved by number of GI fellowships and serving an underserved population. Grants will be awarded based on the strength of the requesting organization's ability to provide expert mentorship, training, and guidance to the fellow.

- Anticipated decision notification date: **June 17, 2024**
- Anticipated project start date: **July 2024 or later**



Funding Range and Project Length

Grant funding is available to support a one year fellowship up to \$80,000.

I. Eligibility

Geographic Scope:

- United States

Applicant Eligibility Criteria

- Accredited, US-based academic institution.
- Do not include the name of the potential fellow(s) in application materials. This grant will be awarded to an institution, not an individual.
- Institutions with fellowship programs that include independent research and a strong mentoring program. Clinical training may be included in the program but is not required.
- No aspect of the fellowship program can benefit Pfizer's business or a Pfizer asset.
- Examples of independent research include: observational studies and outcomes research studies where the primary focus is the scientific understanding of disease; use of screening tools and their impact on improvement of patient health.
 - Examples of research that would **not** be eligible include research involving the study and/or evaluation of any pharmaceutical product and basic science and/or fundamental research (in animal model, in-vitro, etc.).
- Examples of clinical training include: educational time with an interdisciplinary team in review of case examples and relevant didactic training as well as use of tools for improvement in patient health for specific therapeutic areas or conditions.
- Fellow time spent in the clinical setting that is supported through grant funds must not be billed as patient care.

II. Requirements

Date RFP Issued

- February 16, 2024

Specific Area of Interest for this RFP:

- The goal of this RFP is to offer salary support for IBD fellowship programs. Preference will be given to *new* IBD fellowship programs, those that prioritize diversity, equity, and inclusion (DEI) principles, and those with a specific focus on health equity (underrepresented patients, underserved communities).
- It is our intent to support fellowship programs at institutions with clinical training programs in regions where there are continued workforce challenges and that have a strong focus on clinical practice, research, and education to further the understanding of IBD.
- Grants will be awarded based on the strength of the requesting organization's ability to provide expert mentorship, training, and guidance to the fellow.

Requirements for Prospective Fellows:

- Institution must ensure that any fellow that will receive grant funds must be a U.S. Worker (U.S. citizen, permanent resident, refugee, or asylee), or hold an appropriate non-immigrant visa status authorizing employment in the U.S.
- Fellows must hold an M.D. or equivalent degree and are recent graduates from an accredited internal medicine residency program or current fellows in their second or third year of GI training or recent graduates committed to developing a specialized expertise in IBD with a goal of continuing onto a career devoted to the care of patients with IBD.
- U.S. Physician Payments Sunshine Act (“Sunshine Act”) and other transparency law requirements must be satisfied with respect to meals, payments and other transfers of value. As a condition of the grant, the selected fellow will be named in transparency reporting as a recipient of grant funding.

Budget

- Grant funding is available to support one fellow for one year up to \$80,000. The budget can only include salary and support of the fellow benefits.
- Grant funds cannot be used for overhead or indirect costs.
- Funding will be awarded to the institution, not an individual.
- Fellow time spent in the clinical setting that is supported through grant funds must not be billed as patient care.
- No aspect of the fellowship program budget can reflect a benefit to Pfizer’s business or a Pfizer asset.

Review and Approval Process

- A specific grant program RFP uses an expert review panel (ERP) to make final grant decisions.
- The panels are comprised of professionals from the medical community with advanced degrees and expertise in particular clinical areas, or specific needs of a geographic region/learner group, or expertise in research, continuing professional development or quality improvement.
- Proposals will be evaluated based on the following evaluation criteria: fellowship goals, objectives, medical needs and population health, patient care experience, program criteria, mentoring, training opportunities, and resources.

Mechanism by which Applicants will be Notified:

- All applicants will be notified via email by the dates noted above.
- Applicants may be asked for additional clarification during the review period.
