# Pfizer Independent Medical Education Request for Proposals Improving Care for Patients with recurrent/metastatic (r/m) cervical cancer

Competitive Grant Program – Pfizer Internal Review Process

#### **Overview**

This competitive program seeks to provide educational grants to support co-funded continuing education projects focused on the evolving treatment landscape and disease management for patients with r/m cervical cancer.

## **Geographic Scope/Location of Project**

United States

## **Project Types and Area of Interest**

Applicants are encouraged to identify and address the educational needs, barriers, and gaps for patients with r/m cervical cancer relating to treatments, management of adverse events, and long-term outcomes.

Proposed activities should focus on increasing clinicians' knowledge, confidence, competence, and practice changes in caring for patients. This may include interactive learning, case-based learning, workshops, tumor boards, digital platforms, building communities of practice, and other live programs.

## **Key Milestones**

- Application submission deadline: August 22<sup>nd</sup> 2024
- Anticipated decision notification date: September19th 2024
- Anticipated project start date: October 2024

## **Funding Range and Project Length**

Individual co-funded projects requesting up to \$100,000 will be considered. The estimated total available budget related to this RFP is \$500,000.

Expected typical grant range: \$20,000 to \$100,000. For example, smaller, local, or single healthcare institution projects should be at the lower end of this range. Applicants are encouraged to submit requests for projects that have multiple sources of financial support.

Project length should be approximately 12-15 months.



## I. Eligibility

### Geographic Scope/Location of Project:

United States

## Applicant Eligibility Criteria

- Only organizations are eligible to receive grants, not individuals or medical practice groups.
- The following may apply: medical, nursing, allied health providers, and/or pharmacy professional schools; healthcare institutions (both large and small); professional organizations/medical societies; medical education companies; and other entities with a mission related to healthcare professional education and/or healthcare improvement.
- Only organizations are eligible to receive grants, not individuals or medical practice groups (i.e., an independent group of physicians not affiliated with a hospital, academic institution, or professional society).
- If the project involves multiple departments within an institution and/or between different institutions / organizations / associations, all institutions must have a relevant role and the requesting organization must have a key role in the project.
- The applicant must be the project/program lead or an authorized designee of such individual (e.g., project/program lead's grant coordinator).
- The project/program lead must be an employee or contractor of the requesting organization.
- The requesting organization must be legally able to receive award funding directly from Pfizer Inc. We strongly recommend that applicants confirm this with their organization or institution prior to submitting an application. Grants awarded to organizations that are subsequently found to be unable to accept funding directly from Pfizer Inc. may be subject to rescission.
- For projects offering continuing education credit, the requesting organization must be accredited.

## **Clinical Area:**

• Oncology-Gynecological - Cervical Cancer



### General Area of Interest for this RFP:

The goal of this RFP is to support co-funded education for Academic & Community medical oncologists, gynecologic oncologists, pharmacists, eye care providers, nurse practitioners (NP) and physician assistants (PA) working in the oncology setting caring for patients with r/m cervical cancer relating to treatments, management of adverse events, and long-term outcomes.

Projects that will be considered for Pfizer support will focus on addressing the educational needs related to one or more of the following diseases:

- Burden of illness and unmet need of r/m cervical cancer
- Treatment options for r/m cervical cancer
- Disease and adverse event management for cervical cancer patients by comprehensive healthcare team, including non-oncology specialties (e.g. ophthalmology, endocrinology, etc.) as appropriate
- Awareness of new and emerging treatment options in community practice settings treating underserved populations

Proposed activities should focus on increasing clinicians' and care team members' knowledge, confidence, competence, and practice changes in caring for patients. Activity formats that will be considered under this RFP include interactive learning, case-based learning, workshops, tumor boards, digital platforms, and projects to build communities of practice.

#### **Target Audience:**

- Academic & Community medical oncologists, gynecologic oncologists, pharmacists, NP/PAs, and nurses.
- Eye care providers for awareness and education.

#### Expected Approximate Monetary Range of Grant Applications:

- Individual projects requesting up to a maximum of \$100,000 are preferred.
- Expected typical grant range: \$20,000 to \$100,000. For example, smaller, local, or single healthcare institution projects should be at the lower end of this range.
- Grant requests greater than \$100,000 may be considered for exceptional, multi-faceted proposals with detailed budget justification.
- The estimated total available budget related to this RFP is \$500,000.
- Award amounts include direct costs, institutional overhead costs (capped at 28% per Pfizer policy), and indirect costs.

## About Pfizer Global Medical Grants

Pfizer Global Medical Grants (GMG) supports the global healthcare community's independent initiatives (e.g., research, quality improvement, or education) to improve patient outcomes in areas of unmet medical need that are aligned with Pfizer's medical and/or scientific strategies.

Pfizer's GMG competitive grant program involves a publicly posted general Request for Proposal (RFP) that provides detail regarding a general area of interest, sets timelines for review and approval, and uses an internal Pfizer review process to make final grant decisions. Organizations are invited to apply to address the knowledge gaps outlined in the RFP.

For all independent medical education grants, the grant requester (and ultimately the grantee) is responsible for the design, implementation, and conduct of the independent initiative supported by the grant. Pfizer must not be involved in any aspect of project development or the independent education program.



#### **General RFP Submission Requirements**

Applications will be accepted via the online portal listed in the How to Submit section. Project Proposals should be single-spaced using Calibri 12-point font and 1-inch margins. Note there is a 15-page limit exclusive of references. When uploading your Project Proposal please ensure it addresses the following sections:

## **Goals and Objectives**

- Briefly state the overall goal of the project.
- List the objectives you plan to meet with your project, in terms of learning and expected outcomes.

## Needs Assessment for the Project

• Include a description of your organization's needs assessment for this proposed project which may include a quantitative baseline data summary, initial metrics, or a project starting point (please cite data on gap analyses or relevant patient-level data that informs the stated objectives) in your target area.

## **Target Audience**

• Describe the primary audience(s) targeted for this project. Indicate whom you believe will directly benefit from the project outcomes. Describe the overall population size and your sample population.

## **Project Design and Methods**

• Describe the planned project, the educational approach, and the way the planned methods address the established need.

## Innovation

• Explain what measures you have taken to ensure that this project is original and does not duplicate other projects or materials already developed. Describe how this project builds upon existing work, pilot projects, or ongoing projects developed either by your institution or other institutions.

## **Evaluation and Outcomes**

• In terms of the metrics used for the needs assessment, describe how your organization will determine if the gap was addressed for the target group. Identify the sources of data your organization anticipates using to make the determination. Describe how your organization is expected to collect and analyze the data. Explain the method used to control for other factors outside this project (e.g., use of a control group or comparison with baseline data). Quantify the amount of change expected from this project in terms of the target audience. Describe how your organization will determine if the target audience was fully engaged in the project.

## **Dissemination Plan**

• Describe how the project may have extended benefit beyond the grant. Will the teaching materials be made available to others to use? Will there be tools or resources that are made publicly available beyond the initial project. Describe how the project outcomes might be broadly disseminated.
