



# Pfizer Independent Medical Education Request for Proposals

## *Education on the Appropriate Diagnosis and Treatment of Overactive Bladder or Neurogenic Bladder*

Competitive Grant Program –Pfizer Internal Review Process

### Overview

This RFP will support projects aimed at providing education to promote appropriate diagnosis and treatment of overactive bladder or neurogenic bladder.

The scope is not limited to education on overactive bladder or neurogenic bladder, but also includes education on the prevention of complications associated with these conditions.

### Geographic Scope

Japan

### Project Types and Area of Interest

Potential applicants are encouraged to appropriate diagnosis and treatment of overactive bladder or neurogenic bladder.

This may include:

- Education on the diagnosis, treatment, and patient guidance of overactive bladder or neurogenic bladder or the prevention of complications associated with these conditions
- Education to promote team-based care and community health care coordination for overactive bladder or neurogenic bladder
- Education on patient and family communication regarding the diagnosis and treatment of overactive bladder or neurogenic bladder

### Key Milestones

- Application submission deadline: July 30, 2024
- Anticipated decision notification date: October 31, 2024
- Anticipated project start date: January 1, 2025

### Funding Range and Project Length

- Individual projects requesting up to 2,500,000 yen will be considered.
- Anticipated Approximate Project Start and End Dates: January 1, 2025 – December 31, 2025

## I. Eligibility

---

### Geographic Scope:

- Japan

### Applicant Eligibility Criteria

- The following may apply: medical, nursing, allied health, and/or pharmacy professional schools; healthcare institutions (both large and small); professional organizations/medical societies; medical education companies; and other entities with a mission related to healthcare professional education and/or healthcare improvement.
- Only organizations are eligible to receive grants, not individuals or medical practice groups (i.e., an independent group of physicians not affiliated with a hospital, academic institution, or professional society).
- If the project involves multiple departments within an institution and/or between different institutions / organizations / associations, all institutions must have a relevant role and the requesting organization must have a key role in the project.
- The applicant must be the project/program lead or an authorized designee of such individual (e.g., project/program lead's grant coordinator).
- The project/program lead must be an employee or contractor of the requesting organization.
- Requesting organization must be legally able to receive award funding directly from Pfizer International LLC. We strongly recommend that applicants confirm this with their organization or institution prior to submitting an application. Grants awarded to organizations that are subsequently found to be unable to accept funding directly from Pfizer International LLC may be subject to rescission.

### Date RFP Issued

- June 5, 2024

### Clinical Area

- Overactive Bladder or Neurogenic Bladder

### General Area of Interest for this RFP:

Projects that will be considered for Pfizer support will focus on education to promote appropriate diagnosis and treatment of overactive bladder or neurogenic bladder.

Examples of proposals are as follows;

- Education on the diagnosis, treatment, and patient guidance of overactive bladder or neurogenic bladder or the prevention of complications associated with these conditions
- Education to promote team-based care and community health care coordination for overactive bladder or neurogenic bladder
- Education on patient and family communication regarding the diagnosis and treatment of overactive bladder or neurogenic bladder

*IMPORTANT: It is not our intent to support clinical research projects. Projects evaluating the efficacy of therapeutic or diagnostic agents will not be considered. In addition, it is not also our intent to support guideline development (e.g., clinical treatment guidelines) from the viewpoint of COI.*

### Target Audience:

- Persons who are engaged in work or activity related to patients with overactive bladder or neurogenic bladder (health care, nursing care, maternal and child health, education, etc.)
- Persons who work at institutions, organizations or educational institutions that perform operations and activities related to patients with overactive bladder or neurogenic bladder (health care, nursing care, maternal and child health, education, etc.)

### Expected Approximate Monetary Range of Grant Applications:

- Individual projects requesting up to 2,500,000JPY will be considered.

Pfizer Global Medical Grants (GMG) supports the global healthcare community's independent initiatives (e.g., research, quality improvement, or education) to improve patient outcomes in areas of unmet medical need that are aligned with Pfizer's medical and/or scientific strategies.

Pfizer's GMG competitive grant program involves a publicly posted general Request for Proposal (RFP) that provides detail regarding a general area of interest, sets timelines for review and approval, and uses an internal Pfizer review process to make final grant decisions. Organizations are invited to submit an application addressing the knowledge gaps as outlined in the specific RFP.

For all independent medical education grants, the grant requester (and ultimately the grantee) is responsible for the design, implementation, and conduct of the independent initiative supported by the grant. Pfizer must not be involved in any aspect of project development, nor the conduct of the independent education program.

### General RFP Submission Requirements

Applications will be accepted via the online portal listed in the [How to Submit](#) section. Project Proposals should be single-spaced using Calibri 12-point font and 1-inch margins. Note there is a 15-page limit exclusive of references. When uploading your Full Proposal please ensure it addresses the following sections:

#### Goals and Objectives

- Briefly state the overall goal of the project.
- List the objectives you plan to meet with your project, in terms of learning and expected outcomes.

#### Needs Assessment for the Project

- Include a description of your organization's needs assessment for this proposed project which may include a quantitative baseline data summary, initial metrics, or a project starting point (please cite data on gap analyses or relevant patient-level data that informs the stated objectives) in your target area.

#### Target Audience

- Describe the primary audience(s) targeted for this project. Indicate whom you believe will directly benefit from the project outcomes. Describe the overall population size as well as the size of your sample population.

#### Project Design and Methods

- Describe the planned project, the educational approach, and the way the planned methods address the established need.

#### Innovation

- Explain what measures you have taken to assure that this project is original and does not duplicate other projects or materials already developed. Describe how this project builds upon existing work, pilot projects, or ongoing projects developed either by your institution or other institutions.

#### Evaluation and Outcomes

- In terms of the metrics used for the needs assessment, describe how your organization will determine if the gap was addressed for the target group. Identify the sources of data your organization anticipates using to make the determination. Describe how your organization is expected to collect and analyze the data. Explain the method used to control for other factors outside this project (e.g., use of a control group or comparison with baseline data). Quantify the amount of change expected from this project in terms the target audience. Describe how your organization will determine if the target audience was fully engaged in the project.

#### Dissemination Plan

- Describe how the project may have extended benefit beyond the grant. Will the teaching materials be made available to others to use? Will there be tools or resources that are made publicly available beyond the initial project. Describe how the project outcomes might be broadly disseminated.

#### Anticipated Project Timeline

- Provide an anticipated timeline for your project including project start/end dates.

### Additional Information

- If there is any additional information you feel Pfizer should be aware of concerning the importance of this project, please summarize here

### Organization Detail

- Describe the attributes of the institutions / organizations / associations that will support and facilitate the execution of the project and the leadership of the proposed project. Articulate the specific role of each partner in the proposed project.

### Budget Detail

- Please include a budget narrative that describes in greater detail the line items specified in the budget submitted within the application
