This competitive program seeks to support educational symposia at major US dermatology congresses that focus on addressing knowledge and practice gaps specific to atopic dermatitis and alopecia areata.

## **Project Types and Area of Interest**

The landscape of treatment for atopic dermatits and alopecia areata is advancing, with more evidence and breakthrough therapeutic options available to patients. Through this RFP, it is our intent to support educational symposia at major US dermatology congresses that focus on addressing knowledge and practice gaps specific to severity assessment, treatment, and overall care management of adult and adolescent patients suffering from alopecia areata and atopic dermatits. respectively.

# **Funding Range and Project Length**

**Individual projects** requesting up to \$300,000 USD will be considered. The funding of 1-2 projects is anticipated.

Project length will be a maximum of 12 months.



# I. Eligibility

## Geographic Scope/Location of Project:

United States

## Applicant Eligibility Criteria

- The following may apply: medical, dental, nursing, allied health, and/or pharmacy professional schools; healthcare institutions (both large and small); professional organizations/medical societies; medical education companies; and other entities with a mission related to healthcare professional education and/or healthcare improvement.
- Only organizations are eligible to receive grants, not individuals or medical practice groups (i.e., an
  independent group of physicians not affiliated with a hospital, academic institution, or professional
  society).
- If the project involves multiple departments within an institution and/or between different institutions / organizations / associations, all institutions must have a relevant role and the requesting organization must have a key role in the project.
- The applicant must be the project/program lead or an authorized designee of such individual (e.g., project/program lead's grant coordinator).
- The project/program lead must be an employee or contractor of the requesting organization.
- Requesting organization must be legally able to receive award funding directly from Pfizer Inc. We strongly recommend that applicants confirm this with their organization or institution prior to submitting an application. Grants awarded to organizations that are subsequently found to be unable to accept funding directly from Pfizer Inc. may be subject to rescission.
- For projects offering continuing education credit, the requesting organization must be accredited.

## II. Requirements

#### Clinical Area:

Dermatology: Atopic Dermatitis or Alopecia Areata

#### General Area of Interest for this RFP:

Projects that will be considered for Pfizer support will focus on landscape of treatment for atopic dermatits and alopecia areata is advancing, with more evidence and breakthrough therapeutic options available to patients. Through this RFP, it is our intent to support educational symposia at or around major US dermatology congresses that focus on addressing knowledge and practice gaps specific to severity assessment, treatment, and overall care management of adult and adolescent patients suffering from alopecia areata and atopic dermatits, respectively.

Potential applicants are encouraged to address these topics of consideration:

- Clinical management of AD patients inadequately controlled on biologic treatment
- Dose optimization and optimal dose selection for JAKi in AD
- How to identify an appropriate patient with M2S AD for systemic JAKi therapy
- Diagnosis and severity assessment of AA and identification of patients appropriate for systemic treatment



- Long term benefit: risk of treatments for patients with severe AA
- Treatment of adolescents with severe AA

Activities at congresses with be prioritized.

It is not our intent to support clinical research projects. Projects evaluating the efficacy of therapeutic or diagnostic agents will not be considered.

## **Target Audience:**

• The target audience for the project should include dermatologist, pediatric dermatologists, nurses, nurse practitioners, and/or physician assistants who treat AD or AA.

## **Expected Approximate Monetary Range of Grant Applications:**

- **Individual projects** requesting up to \$300,000 will be considered. The funding of 1-2 projects is anticipated.
- Award amounts include direct costs, institutional overhead costs (capped at 28% per Pfizer policy), and indirect costs.

Applications will be accepted via the online portal listed in the How to Submit section. Project Proposals should be single-spaced using Calibri 12-point font and 1-inch margins. Note there is a 15-page limit exclusive of references. When uploading your Project Proposal please ensure it addresses the following sections:

## Goals and Objectives

- Briefly state the overall goal of the project.
- List the objectives you plan to meet with your project, in terms of learning and expected outcomes.

## Needs Assessment for the Project

• Include a description of your organization's needs assessment for this proposed project which may include a quantitative baseline data summary, initial metrics, or a project starting point (please cite data on gap analyses or relevant patient-level data that informs the stated objectives) in your target area.

## **Target Audience**

Describe the primary audience(s) targeted for this project. Indicate whom you believe will directly benefit
from the project outcomes. Describe the overall population size as well as the size of your sample
population.

## **Project Design and Methods**

 Describe the planned project, the educational approach, and the way the planned methods address the established need.

#### Innovation

• Explain what measures you have taken to assure that this project is original and does not duplicate other projects or materials already developed. Describe how this project builds upon existing work, pilot projects, or ongoing projects developed either by your institution or other institutions.

#### **Evaluation and Outcomes**

• In terms of the metrics used for the needs assessment, describe how your organization will determine if the gap was addressed for the target group. Identify the sources of data your organization anticipates using to make the determination. Describe how your organization is expected to collect and analyze the data. Explain the method used to control for other factors outside this project (e.g., use of a control group or comparison with baseline data). Quantify the amount of change expected from this project in terms the target audience. Describe how your organization will determine if the target audience was fully engaged in the project.
