

Pfizer Independent Medical Education Request for Proposals

PARP-inhibitor Combination Treatments: Efficacy and Safety in a New Era of metastatic Castration Resistant Prostate Cancer

Competitive Grant Program – Pfizer Internal Review Process

#### Overview

This competitive grant seeks to increase healthcare professional understanding of treatment options in a new era of metastatic Castration Resistant Prostate Cancer (mCRPC) with PARP-inhibitor (PARPi) combination treatments in order to maximize patient benefit.

## Geographic Scope/Location of Project

China

# **Project Types and Area of Interest**

Projects that will be considered for Pfizer support will focus on:

- increasing understanding of emerging data on the efficacy and safety of PARPi's in the treatment of mCRPC.
- improving awareness and the adoption of best practices in testing.
- improving awareness of clinical data regarding PARPi combination—vs. mono-therapy.
- education around recent updates to and interpretation of guidelines and consensus statements.
- educational tools/resources to integrate support and patient communication.

## **Key Milestones**

- Application submission deadline: March 18, 2025
- Anticipated decision notification date: May 6, 2025
- Anticipated project start date: June 3, 2025

## **Funding Range and Project Length**

Individual projects requesting up to \$80,000 will be considered. The estimated total available budget related to this RFP is \$350,000.

Maximum project length is 1.5 years.



# I. Eligibility

### Geographic Scope/Location of Project:

China

### Applicant Eligibility Criteria

- The following may apply: medical, nursing, allied health, and/or pharmacy professional schools; healthcare institutions (both large and small); professional organizations/medical societies; medical education companies; and other entities with a mission related to healthcare professional education and/or healthcare improvement.
- Only organizations are eligible to receive grants, not individuals or medical practice groups (i.e., an
  independent group of physicians not affiliated with a hospital, academic institution, or professional
  society).
- If the project involves multiple departments within an institution and/or between different institutions / organizations / associations, all institutions must have a relevant role and the requesting organization must have a key role in the project.
- The applicant must be the project/program lead or an authorized designee of such individual (e.g., project/program lead's grant coordinator).
- The project/program lead must be an employee or contractor of the requesting organization.
- Requesting organization must be legally able to receive award funding directly from Pfizer Investment
  Co., Ltd. We strongly recommend that applicants confirm this with their organization or institution prior
  to submitting an application. Grants awarded to organizations that are subsequently found to be
  unable to accept funding directly from Pfizer Investment Co., Ltd. may be subject to rescission.

# **II. Requirements**

#### Date RFP Issued:

• February 7, 2025

#### Clinical Area:

Oncology – Genitourinary – Prostate

#### General Area of Interest for this RFP:

- Independent Education Projects that will be considered for Pfizer support will focus on:
  - emerging data on efficacy and safety regarding PARPi's used in the treatment of mCRPC, including better understanding of: 1) the mechanism of action and the biological and clinical rationale for PARPi combinations and; 2) clinical safety, treatment sequencing and patient subgroup data, inclusive of previously treated mCRPC patients.
  - improving knowledge of testing in prostate cancer, including when/who/why to test; germline and somatic testing; etc.
  - best practices in testing, including how to order and interpret results of biomarkers and genetic mutations (inclusive of BRCA and non-BRCA) and its application to therapy management.
  - clinical data regarding PARPi combination vs. mono- therapies and how to mitigate associated side effects for optimal patient care.



- recent updates to guidelines and the scientific consensus for optimal therapy management of PARPi combinations in prostate cancer.
- Educational tools/resources to integrate support and patient communication during treatment via patient education and therapy management.

It is not our intent to support clinical research projects. Projects evaluating the efficacy of therapeutic or diagnostic agents will not be considered.

### **Target Audience:**

• Oncologists and other healthcare professionals involved in the care and treatment of prostate cancer

### **Expected Approximate Monetary Range of Grant Applications:**

- Individual projects requesting up to \$80,000 will be considered. The estimated total available budget related to this RFP is \$350,000.
- Award amounts include direct costs, institutional overhead costs (capped at 28% per Pfizer policy), and indirect costs.

## General RFP Submission Requirements

Applications will be accepted via the online portal listed in the How to Submit section. Project Proposals should be single-spaced using Calibri 12-point font and 1-inch margins. Note there is a 15-page limit exclusive of references. When uploading your Project Proposal please ensure it addresses the following sections:

### Goals and Objectives

- Briefly state the overall goal of the project.
- List the objectives you plan to meet with your project, in terms of learning and expected outcomes.

### Needs Assessment for the Project

• Include a description of your organization's needs assessment for this proposed project which may include a quantitative baseline data summary, initial metrics, or a project starting point (please cite data on gap analyses or relevant patient-level data that informs the stated objectives) in your target area.

## **Target Audience**

Describe the primary audience(s) targeted for this project. Indicate whom you believe will directly benefit
from the project outcomes. Describe the overall population size as well as the size of your sample
population.

### **Project Design and Methods**

 Describe the planned project, the educational approach, and the way the planned methods address the established need.

#### Innovation

• Explain what measures you have taken to assure that this project is original and does not duplicate other projects or materials already developed. Describe how this project builds upon existing work, pilot projects, or ongoing projects developed either by your institution or other institutions.

#### **Evaluation and Outcomes**

• In terms of the metrics used for the needs assessment, describe how your organization will determine if the gap was addressed for the target group. Identify the sources of data your organization anticipates using to make the determination. Describe how your organization is expected to collect and analyze the data. Explain the method used to control for other factors outside this project (e.g., use of a control group or comparison with baseline data). Quantify the amount of change expected from this project in terms the target audience. Describe how your organization will determine if the target audience was fully engaged in the project.
