Pfizer Questionnaire Privacy Statement

This privacy statement relates to a questionnaire (the "Questionnaire") that is to be completed by or on behalf of a company, entity or individual (the "Applicant") who or that is proposing to enter into an engagement with Pfizer and/or receive funding or other support from Pfizer. Collection and use of information

Please note that in the Questionnaire we request personal information. The information that we request and you provide in response to the Questionnaire may include information relating to identifiable individuals, such as names, contact information, banking information, business/organization detail, criminal investigations, and associations with Government Officials. Personal information will be processed by Pfizer in order to comply with legal requirements, including to prohibit corrupt payments to Government Officials for the purpose of obtaining or retaining business.

You may be obligated under relevant laws to provide notice to the individuals whose personal information you provide and to obtain their consent to the collection, use, and disclosure of their personal information. By submitting personal information via this Questionnaire, you represent that you have provided any applicable notices and obtained any required consents.

Pfizer may also collect information from sources other than the specific Questionnaire you submit. This information may be obtained from Pfizer's existing records and/or from third party sources, such as databases utilizing publicly accessible information and occasionally private entities that collect information on our behalf.

The information collected through or associated with the Questionnaire (the "Information") will be analyzed to evaluate risks related to anti-corruption laws and may be used to perform background checks. Completion of the Questionnaire is voluntary. However, if the Applicant fails to complete the Questionnaire, or is unable to provide all of the required information, Pfizer may be precluded from doing business with the Applicant or from providing the relevant funding or support.

Information disclosure and cross-border transfers

The entity responsible for the processing of personal information for purposes of the Questionnaire is the Pfizer entity that is proposing to enter into an engagement or provide funding or other support to the Applicant. That entity will provide the Information to Pfizer, Inc., a US corporation, which will hold the Information in the United States for its own compliance purposes. Some information from this Questionnaire will be made available to all Pfizer group entities worldwide so that they are aware that the Questionnaire has been completed should they propose to enter into an engagement with the Applicant in the future. In some circumstances Pfizer affiliates will be granted access to the full Information collected. In some cases, a third party supplier receives access to Information so that it can process it on behalf of another member of the Pfizer group, as a service provider, under strict conditions of confidentiality and security. If a potential compliance concern is identified, the Information will be further considered by Pfizer

and/or may be disclosed to Pfizer's external legal counsel and/or may be disclosed to federal, state, national or local regulatory authorities in the US or other countries.

As mentioned above, personal information may be transferred to the United States or other countries that may have varied privacy laws. With respect to the European Economic Area (EEA), we have put in place adequate measures, such as standard contractual clauses adopted by the European Commission, to protect personal information.
