

# LIVING WITH RHEUMATOID ARTHRITIS (RA):

# TAKING ACTION TO DEFINE YOUR RA NarRAtive

The RA NarRAtive global survey, fielded among 3,649 people living with RA, reveals the need for patients to feel comfortable in talking with their healthcare professional and speaking up about RA treatment goals and preferences in order to help improve management of their RA.

You can define your RA NarRAtive by working to break down barriers to receiving optimal care.

### THE PHYSICAL AND EMOTIONAL **BURDEN REMAINS\*:**

#### Nearly 1 in 2 (47%)

of all patients with RA have stopped doing or participating in certain activities<sup>10</sup>

About 3 in 10 have quit or changed jobs, or stopped working altogether due to their RA11

#### : Take Action Set realistic goals and share them with your healthcare professional to help find ways for you to achieve them. Keep the conversation going and focus on

your goals!

### **COMFORT LEVEL WITH YOUR HEALTHCARE** PROVIDER CAN POSITIVELY IMPACT YOUR **DISEASE MANAGEMENT:**

Patients with RA who are comfortable raising concerns/fears are:

43% more likely to have positive view on health – good/excellent\*5

90% more likely to be satisfied with their RA medication regimen\*\*6

# Take Action

Connect with your local advocacy organization to help prepare for doctor visits. Be honest about how you feel and know the right questions to ask to ensure that each visit leaves you empowered to better manage your RA.

### **DISCONNECTS EXIST BETWEEN** TREATMENT SATISFACTION AND STATUS OF DISEASE:

4 in 5 people say they are satisfied with their RA treatment regimen; however, only 30% say their RA is "under control"\*8

More than 1 in 2 wish they had more medication options\*9

Get the most from your treatment and explore your options. If you don't feel your RÁ is "under control," talk with your doctor about your options.

## **Take Action**

Say what's on your mind. When you are comfortable expressing concerns and setting goals jointly with your doctor you are more likely to experience positive treatment outcomes.

### WHAT IS THE RA NarRAtive PATIENT SURVEY?

The RA NarRAtive patient survey was fielded among **3,649 adult RA patients in 13 countries**, including Argentina, Australia, Brazil, Canada, France, Germany, Italy, Japan, South Korea, Spain, Turkey, United Kingdom, and the United States.<sup>12</sup>
