A. Administrative and Compliance Rigor

- 1. Completeness of application
- 2. Eligibility and qualifications of applicant
- 3. Compliance with all applicable laws, policies and guidelines
- 4. Amount requested approximately within CGA posted range
- 5. Alignment to goal
- 6. Medical and scientific accuracy
- 7. Project management plan with payment milestones

B. Educational Quality

- 1. Depth and specificity of needs assessment
- 2. Project aims or educational objectives based upon identified needs
- 3. Educational methods and design
- 4. Outcomes measurement and expected results
- 5. Plan for continuous assessment

C. Transparency and Public Domain Availability

- 1. Degree of public transparency, publication plan, and availability of all resources, methods and results.
- 2. Degree of collaboration with organizations representing recognized best practices for project elements.
- 3. Overall quality and importance
